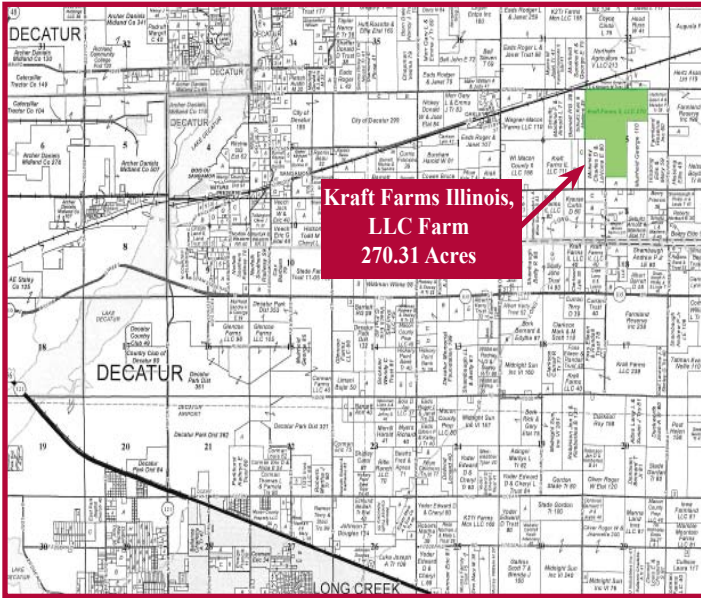

▼ Legal Description

The Northwest 1/4, the North 60 acres of the East 1/2 of the Southwest 1/4 and the West 20 feet of Lot 5 of Assessor's Plat in Book 335, Page 616, and the North 55 acres of the West 1/2 of the Northeast 1/4, all in Section 5, Township 16 North, Range 4 East, Oakley Township, Macon County, Illinois, EXCEPT therefrom that part thereof lying West of a hedge line of which is described in the deed recorded in Book 52 at Page 117 of Macon County Deed Records, which line is so described as follows: Beginning at the Southwest corner of the East Half (1/2) of the Southwest Quarter (1/4) of said Section Five (5), thence Northerly along said hedge 40.02 chains to a point thirty-four (34) links East of the Northwest corner of the East Half (1/2) of said Southwest Quarter (1/4) of said Section Five (5), thence Northerly along said hedge 14.98 chains to a stone eighteen (18) links East of the West Line of the Southeast Quarter (1/4) of the Northwest Quarter (1/4) of said Section Five (5), as per Plat of Survey dated November 17, 2010, by Robert L. Cox, Illinois Professional Land Survey No. 2442. Situated in Macon County, Illinois.

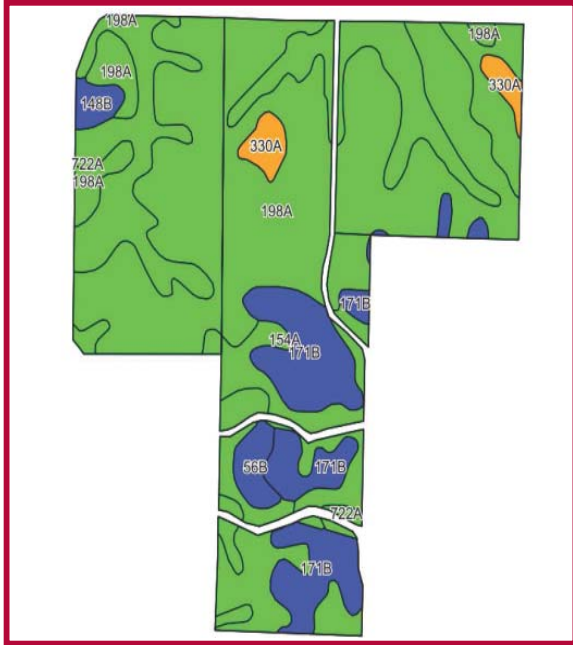
